TERMS OF THE SFSF VENDOR APPLICATION & AGREEMENT

The 9th Annual Shelby Forest Spring Fest will be held April 18, 2020 at the old UA Moore Ballpark in Meeman Shelby Forest. **RAIN DATE IS APRIL 19TH.** The park is located about 1.5 miles past the Shelby Forest General Store and E.E. Jeter Elementary School at 7097 Benjestown Rd. Millington, TN 38053. The festival will run from 10am - 6pm.

Your space: A 10x10, 20x10, or 30x10 will be set aside for your booth area based on what you checked on your application. If you need more than 30ft please contact us for special pricing. Vendors will also have to provide a 100ft outdoor extension cord if electricity is being purchased. All vendors are responsible for their booth area. All materials and refuse shall be removed by the vendor at the conclusion of the festival. Vendors will provide their own tents, tables, chairs, etc. for their display. SFSF PERSONNEL RESERVES THE RIGHT TO REQUEST THE REMOVAL OF ANY OBJECTIONAL ITEMS FROM THE VENDOR'S BOOTH. Vendors MAY NOT SELL CANNED OR BOTTLED DRINKS from their tents unless you are certified as a concessions vendor by SFSF personnel. Each vendor will receive up to (4) badges at check in. If more than 4 are needed, you may purchase up to 2 more at the discounted price of \$2 each. The public will be charged a \$5 entrance fee to attend this year.

Set Up: When you first arrive, you will be guided toward the vendor check in booth. This is where you will receive your badges and a SFSF team member will guide you to your predetermined space.

VENDORS MAY START SETTING UP THEIR BOOTH AREA AT 7AM AND ALL SET UP MUST BE

COMPLETED BY NO LATER THAN 9:45AM. NO VENDOR WILL BE ADMITTED LATE TO SET

Parking: There will be special designated parking set aside for vendors in the parking lot. Due to space limitations, NO VENDOR VEHICLES OR TRAILERS MAY BE PARKED BY YOUR SPACE(S). ALL VEHICLES AND TRAILERS MUST BE MOVED TO THE DESIGNATED PARKING AREA NO LATER THAN 9:45AM.
